

Compensating Hit and Run victims

Pioneered in 2015, Government has established the IICF to provide compensation to:

- i) Insurance policy holders whose insurance company has become insolvent (Insolvency Sub Fund);
- ii) Hit and Run victims who have no legal and financial remedies following a hit and run accident (Hit and Run Sub Fund).

Hit and Run Sub Fund

Effective since January 2016, the Hit and Run Sub Fund plays a very crucial role in compensating and providing assistance in kind to Hit and Run victims in Mauritius and Rodrigues.

Mission

Payment of compensation to persons suffering from personal injury sustained in a hit and run road traffic accident.

Vision

To provide the best assistance and support to hit and run victims and their heirs

Objectives

To work in close collaboration with Mauritius Police Force to create a database to identify each and every victim of Hit and Run and indemnify them. To perform beyond our scope of competence to become a role model institution like our international counterparts.

We aim to become one of the pioneering institutions in the insurance industry where the Public is gaining more trust and confidence in the insurance sector. We will use our best endeavors to cater for every Hit and Run victim across Mauritius and Rodrigues. We will use our expertise and wisdom to bring tailor-made amendments in our legislation to fulfil the needs of our beneficiaries and their heirs respectively.

More than 100 families have been assisted and 92 have been duly compensated in the sum of MUR 11.6 million.

Eligibility

- You have been involved in a Hit and Run accident where the driver is untraceable;
- You have suffered personal injuries or you lost a close one;
- The police has been unable to trace the driver within 3 months;
- 5 years must not have elapsed since the date of the accident;



How to apply for a claim

Required Documents

The victim/claimant needs to fill a Hit and Run claim form available online or at the IICF office with the following supporting documents:

- National Identity card/Birth certificate of the victim
- National Identity card/Birth certificate of the claimant (if not the victim)
- Copy of witness details & statement if any
- Copy of police report if available
- Death certificate (if applicable)
- Affidavit of filiation/deed of notoriety (if applicable)

Under sections 88 and 92 of the Insurance Act 2005, the Minister enacted the Insurance (Industry Compensation Fund) Regulations 2015, which were published in December of that year.

Compensation amounts can range from 100,000 rupees to 1 million rupees, depending on the specific category.

Benefits of IICF's Hit and Run Sub Fund

- You do not need to own any insurance policy;
- It is free;
- Only provide personal information;
- IICF will liaise with Mauritius Police Force for police enquiry documents;
- IICF will liaise with hospitals or private clinics to obtain medical reports;
- Waiting time is 6 months once all documents have been obtained;
- Compensation credited straight to your account;
